INTENSIVE SUMMER WORKSHOP ON ETHICS AND RESEARCH (I-SWEAR)

The Background:

Over the past two decades, side by side with the growth of clinical trials in India, Institutional Ethics Committees (IEC) have also increased. As per the Indian Council for Medical Research (ICMR) survey conducted in 2003, there were 223 IECs in the country and only 39% of these reported some members to have some form of training in bioethics. In a more recent study (2011) covering 11 IECs the rate had climbed to about 50% though response rate was also 50%.

Regardless, it is clear that the country still needs more persons trained in bioethics, so that their contribution within the IEC becomes more meaningful. In light of the recent trial-related deaths, a public interest litigation was led before the Hon'ble Supreme Court. In 2012 the Supreme Court banned all new clinical trials across the country and pressurized the Government of India to take action to improve the regulations relating to clinical trials. Presently it is mandatory for a clinical trial to register with the Clinical Trials Registry of India (www.ctri.nic.in). Additionally, the Government appointed eminent scientist (Late) Prof Ranjit Roy Chaudhury to head a committee to formulate new and stronger policies and guidelines. This committee was formed in February of 2013 and published its report in October 2013. Many researchers and ethicists are unfamiliar with the transition, thus this workshop. Based on this report, EC's have to register with the office of the DCGI to be eligible to do ethical review of clinical trials.

The Event:

The main focus of the Intensive Summer Workshop on Ethics and Research (I-SWEAR) is to empower participants who are presently engaged in research or are serving on institutional ethics committees; or are likely to serve in the coming years – to give them the knowledge and tools to recognize and deal with various ethical issues arising out of research being done on human subjects. The course will also train participants in Good Clinical Practice (GCP) along guidelines of the International Council for Harmonization (ICH).

This four-day Intensive Summer Workshop on Ethics and Research (I-SWEAR) program runs from Monday to Thursday (9am to 4.30pm) and is spread o ut over 16-20 sessions. The topics covered are of great relevance to the present day scenario of biomedical research in India, and are structured using the current guidelines of the Indian Council of Medical Research, Schedule Y of the Drugs and Cosmetics Act, the ICH-GCP and other national and international guidelines.

The Organizers:

Centre for Ethics was established in February 2011 by Yenepoya University, the rst deemed university in Dakshina Kannada, recognized by the MHRD under Sec 3A of the UGC Act 1956 and accredited A Grade by NAAC. The Centre was created with the objectives of bringing about a renaissance in the subject of Medical Ethics as taught in Medical colleges. The Centre conducts several innovative academic programs including a one-year postgraduate diploma in bioethics & medical ethics (PGDBEME) and post graduate diploma in Clinical Ethics (PGDCE).
